ELIGIBILITY

Adults (18 and older) who live, work or go to school full-time in Caldwell County.

ENTRY FEE

A non-refundable entry fee of \$10 entitles the artist to display up to two (2) works in this competition.

SPECIFICATIONS

- Work must be delivered to the Caldwell Arts Council either Monday or Tuesday, October 3-4, 9am-5pm.
- Work must be picked up on Monday, October 31, 9am-5pm; another exhibit is arriving the next day.
- All artwork must remain in the gallery for the duration of the exhibit.
- Artwork may be 2-dimensional (paintings, collage, etc.) or 3-dimensional (pottery, small sculptural, etc.) and no older than one year.
- Photography & pieces displayed previously at Caldwell Arts Council or Sculpture Celebration are excluded from this competition.
- Works that are meant to hang on the wall must be framed & in a finished state and ready to hang (hooks and/or hanging wire attached) — no dry-mount or other temporary hanging formats.
- Installation pieces are welcome, but the artist must be available on Wednesday afternoon, October 5th to help install with the hanging committee—or if there are special installation instructions, they should be attached to the piece; diagrams are helpful.
- Any piece not fulfilling the criteria will be pulled from the exhibit and the entry fee will be forfeited.
- The Caldwell Arts Council reserves the right not to display every piece submitted.

SALES

Artwork may be marked for sale or not for sale. The Caldwell Arts Council retains a 30% commission on all sales. Any work not for sale should have an insurance value indicated. Once price/insurance value of a piece is specified, it shall remain for the duration of the exhibit. The Caldwell Arts Council will conduct all sales transactions.

JUDGE

Betty Powell received a Bachelor of Science in Art Education from Appalachian State University. After working as a visual art educator in Wilkes County Schools for many years, Powell focused her attention on creating artwork, pursuing a Masters of Art degree, and studying with many well-known pastel artists including Wolf Kahn and Charles Basham. Powell has received numerous awards throughout the years including Best in Show and 1st Place in Paintings at the Wilkes Art Gallery's Northwest Artist's League Juried Competition. Powell's pastels, paintings, and mixed media collages are included in private and public collections across the South.
